Membership Fees (\$117 per year)

- Authorise NTUC or its Agency to obtain NTUC Membership Fees [current fees being \$9 per month (Jan-Nov); \$18 (Dec)] from me in accordance with the prevailing rates of Union/Association subscriptions. The cycle repeats automatically for the following year.

Rules
